Acute Effects

Citrus terpenes have been shown to have low oral toxicity (LD50 > 5 g/kg) and low dermal toxicity (LD50 > 5g/kg) when tested on rabbits. Citrus terpenes also showed low toxicity by inhalation (RD50 > 1g/kg) when tested on mice. The skin irritancy od limonene in guinea pigs and rabbis is considered moderate and low, respectively, Inhlation may cause irritation of the nose, throat, and respiratory tract.

Chronic Effects

This product is not classified as a carcinogen by OSHA, IARC, ACGIH, or NTP. This product has not been shown to produce genetic changes when tested on bacterial or animal cells. This produt does not contain known reproductive or developmental toxins. Prolonged or repeated exposues can cause drying or dermatitis of skin improper storage and handling may lead to the formation a possible skin sensitizer.
